Our Mission

North Star of Chester County, formerly Interfaith Housing Assistance Corporation of Chester County, guides Chester County's single working parents with dependent children, who are at risk of homelessness, toward stability and financial independence. We help our participant families remain in clean, safe, affordable housing as they work to secure their future through a structured program of financial assistance, mentoring and supportive services.

Single parents who stay in our program for three full years emerge stable and proudly able to provide for their families.

A MESSAGE FROM OUR EXECUTIVE DIRECTOR

Dear friends.

North Star parents are hardworking single moms and dads who do not have a safety net. They are the face of what the United Way has designated ALICE (Asset-Limited Income Constrained Employed) families. Families who work but can not afford the basic necessities of life including housing, childcare, healthcare, transportation, and food. There are more than 10,000 ALICE single parent families in Chester County. Their wages are low, their rents continue to rise, they earn too much to qualify for most assistance programs but are struggling to make it on their own.

In the last year, 53 single parents came through our doors, looking for support and guidance. We are grateful that all of our ALICE families remained in their homes while enrolled in our program and we are honored to be a part of their journey toward self-sufficiency. Our families still face many challenges including the ongoing lack of affordable housing, insufficient public transportation, stagnant wages, and cuts to benefits. We are committed to serving them, providing the support and guidance they need now so they can flourish in the future. We believe an investment in our families is an investment in the entire community and we remain committed to

helping them succeed.

Served **145** single parents and children

96% of parents served were single mothers

Paid more than \$39,000 in rental assistance to keep 26 Chester County families in their homes



4,960 nights of homelessness prevention generated by our rental assistance



Together, our efforts helped raise more than \$85,000 to support our homelessness prevention & self-sufficiency program.

North Star of Chester County hosted several workshops related to selfsufficiency including employment, credit scores, child support, and legal aid.




